REPORTS:

EXECUTIVE DIRECTOR'S REPORT: Monthly report submitted to Executive Committee including monthly Fast-Track Accident Frequency, Fast-track financial report, Claim Activity Report, Claims Management Exception Report, Interest Rate Summary Comparison, Monthly Loss Ratio by fund year and line of coverage and Monthly and Annual Regulatory Checklist. Executive Director said Financial Fast Track Report as of October 31st shows our statutory surplus stands at \$5.1 million up about \$600,000 from year end, all years are positive with the exception of 2016 year which has a deficit of \$300,000. Executive Director said this could improve because a lot of the deficit is in reserves and IBNR. The Loss Ratio Analysis through October 31st shows the Fund is just at or slightly above the actuarial target in 2016 and 2017. The Fund's Lost Time Accident Frequency stands at 1.67 which is better than last year where we were at 2.30. Executive Director reviewed the POL/EPL Compliance Status Report and said QBE reviews each member and decides on an annual basis whether or not they think they need to make any changes to the deductibles and pricing. They have already done their review and they are going to renew everyone at the expiring deductibles and co-pays for this JIF.

EJIF – The EJIF Board of Fund Commissioners met on November 15th at the Sheraton Hotel in Atlantic City. Enclosed is a copy of Commissioner Rutkowski's report on the meeting. Executive Director said the underground storage tank policy is completely rewritten and it is not expected to change any coverage and that policy was in place since 1977 so they worked with the excess carrier to update it. Commissioner Rutkowski said the transit coverage was finalized. Executive Director said we had discussed previously in this JIF that we did not have "upset during transit" coverage. If your materials were upset while in transit there was no coverage. We temporarily covered in our retention while the EJIF worked that out. In December the EJIF agreed to provide a supplement for that coverage.

MEL – The MEL Board of Fund Commissioners conducted its public hearing on the 2018 budget on November 15th in the Atlantic City Convention Center. Enclosed is a copy of Commissioner Rutkowski's report on the meeting – with adopted budget attached.

Executive Director said the Cyber Task developed minimum risk control standards and everyone should have received an email of the NJ MEL Cyber Risk Management program from Alex Deluccia. The requirements are fairly minimal in order to recover the deductible. It is not the end all be all and you can certainly go beyond those standards.

Executive Director said everyone should have received a card for the MEL mobile application and we discussed it at the League. We encourage everyone to download the app and identify your roll so you will receive push alerts that are helpful to you.

Executive Director said there was a bulletin on changes to the Land Use Policy that said it did not affect or apply to the NJUA members but the way that it does not apply is because the way the exclusion was written and now changed was that any land use arising out of a decision at the planning board and the zoning board so in that sense it does not affect you. They did increase the limit to \$1 million and it will be in your policy it is just that you likely you will not have a claim because you do not have a zoning board.

2018 MANAGED CARE – The Fund reviewed RFQ responses in September for all Fund professionals except Managed Care – to allow for the Fund to perform a "market basket" review (review of network discounts). The Finance Committee will provide a report at the meeting. Executive Director said the Finance Committee did meet and because it is a contract matter we should discussion in closed session.

2018 BUDGET – In accordance with regulations, the budget adopted by the Fund has been advertised in the Fund's official newspaper. In addition, PERMA mailed the budget to member authorities and is in the process of filing with the state.

2018 BILLINGS – In accordance with the Fund's bylaws, bills have been mailed to member authorities and are due and payable by January 15, 2018. Any payments not received by February 1, will be subject to a late penalty retroactive to the due date. Executive Director said the elected officials credit is not being applied as a credit rather than reducing your assessment.

NOMINATING COMMITTEE – The Nominating Committee met in November and recommends the enclosed slate for Chairman, Secretary and Executive Committee in 2018. Following the December meeting we will distribute ballots to Fund Commissioners. Executive Director said the Board met in November and on page 7 you will find their recommended slate. If the Board approves that we will issue a ballot following today's meeting. Executive Director said we do the ballot because we are not always guaranteed that we will have a quorum at the January meeting. If we have quorum we will do the election live but if we do not have a quorum we will rely on the ballots.
